

MSURJ Publication Rights Agreement (Abstracts)

This form is sent on behalf of the McGill Science Undergraduate Research Journal (MSURJ), which is the licensee. The purpose of this Publications Rights Agreement (PRA) is twofold:

1. Introduce MSURJ and outline the implications of publishing in this undergraduate journal;
2. Obtain permission from all co-authors and relevant parties involved in the research (e.g., supervisors, principal investigators, lab managers) so as to proceed with publishing.

I. Introduction

The McGill Science Undergraduate Research Journal (MSURJ) launched in Fall 2005 as a student-run initiative to benefit the undergraduate research community. Our mission is to encourage, publish, and promote undergraduate research. This key resource unites student researchers, student editors, faculty supervisors, graduate students, and faculty reviewers. As an undergraduate journal drawing on peer reviews from around the world, this journal intends to provide aspiring undergraduates with valuable experience in the process of writing and publishing peer-reviewed academic articles.

II. Abstract Publication Process

Abstracts submitted for publication will be reviewed by the MSURJ Editorial Board for formatting and completeness. Accepted abstracts will be published in MSURJ. Submission of an abstract is not a guarantee of publication.

III. Authorship, rights, and uses

MSURJ is an open-access and non-proprietary journal. The licensor agrees to license the submitted abstract under a [Creative Commons Attribution 4.0 International License](#). Authors retain all copyrights to their research work and grant MSURJ the non-exclusive, non-assignable, irrevocable rights, unlimited in time and territory and without claim of compensation, to copy-edit, reproduce, publish, and distribute the accepted abstract. The authors also grant MSURJ the right to use the abstract in whole or in part in electronic form. This includes interactive media and multimedia, posting the abstract in full or in part on social media, and the right to alter the abstract to the extent necessary for such use. The authors grant MSURJ the right to deposit abstract metadata with CrossRef for the primary purpose of obtaining DOIs for published abstracts and to deposit this intellectual property with the Public Knowledge Project Preservation Network for archival purposes if MSURJ ceases operations. Publication of this abstract does not constitute prior publication of the complete work, and authors explicitly maintain the right to publish the full research as a complete paper in any venue.

IV. Consent

Research carried out in collaboration with professors and other students requires that all authors approve abstract submission. All co-authors, primary investigators, and other relevant parties with claims to the intellectual property of the submission must indicate their consent for the author(s) to proceed with publishing in MSURJ.

In addition to the below statements, all co-authors certify that they approve of the submitted abstract, agree for their name to be publicly associated with such abstracts, and are personally accountable for their contributions to the submitted work. All co-authors certify that the work is their own.
